

# One-off Advice Fee: Consent & deduction from TelstraSuper account

Complete and sign this form to provide your consent and authorise Telstra Super Pty Ltd (ABN 86 007 422 522, AFSL 236709), the trustee of TelstraSuper, to deduct some or all of the payment of the advice fee as detailed below from your TelstraSuper account to pay TelstraSuper Financial Planning (TSFP) for the provision of one-off (non-ongoing) personal advice to you. As part of that personal advice you will be provided with a Statement of Advice (SOA) which covers advice on your superannuation arrangements.

## Important information

- TelstraSuper is required by law to obtain your written consent before the fee for financial advice can be deducted from your super account. If you are not happy with the amount or the services described, you do not have to sign this consent
- TelstraSuper will deduct the amount from your super account on the day of the issue of the SOA, or shortly after
- If you have more than one TelstraSuper account you can nominate the account from which the advice fee is to be deducted
- If there are insufficient funds in your nominated TelstraSuper account we will contact you to make arrangements for the payment of the advice fee
- The advice fee will be deducted proportionately from the investment options in which your account is invested (excluding the Direct Access option)
- Your consent expires once the amount is deducted from your TelstraSuper account. To deduct fees from your super account for further advice from TelstraSuper Financial Planning, we will need to obtain your consent again.

However, **your withdrawal of this consent must occur before TelstraSuper has deducted the amount from your super account.**
